

GLEN OAKS VILLAGE PARKING PERMIT APPLICATION

Parking permits are valid through January 31 of the year following the permit year

Glen Oaks Village has many private outdoor parking areas on the property. Vehicles that are parked in these areas require an annual parking permit that must be affixed to the vehicle's passenger side windshield. Vehicles parked without the proper permit will be stickered, fined and subject to towing at owner's expense. All parking permit applicants must reside in Glen Oaks Village and show proof that the vehicle being registered is owned by them or a family member residing in Glen Oaks Village. As a convenience to your family and visitors, parking permits may be transferred between vehicles at any time. The owner assigned to the permit is responsible for all vehicle/parking related house rule violations issued to the vehicle in which the permit was used. Parking permits are inexpensive and will not be prorated at time of purchase. Glen Oaks Village Owners, Inc. is not responsible for damage or theft of any vehicle parked on our property. Parking Permits are available at the Management Office 70-33 260th St. M-F 9AM to 4:30PM and Saturdays at the Maintenance Office, 70-41 260th St. 10AM-3PM.

Garage Information: *There is a waiting list for indoor garages. If you are interested in a garage, place your name on the garage waiting list at the Management Office for your building section. You may enter your name on up to 3 nearby garage sections.*

PERMIT APPLICATION PROCEDURE:

1. Fill out the Parking Permit Application below for each permit requested (maximum of 2 per family) and make a copy of the vehicle registration that is owned by you or a family member residing in GOV.
2. Enclose a check made payable to Glen Oaks Village Owners, Inc. or GOVO, Inc. Mail or hand-deliver all information with payment to the Management Office at 70-33 260th Street.
3. Place the Parking Permit at the bottom of the passenger side windshield. Remember to remove your parking permit if you replace your vehicle during the year. If a permit is lost or destroyed, you may apply for a replacement permit at no additional cost and the old permit # will be cancelled.
